CIRCULAR 15 OF 2024 – 2024 AFFILIATION

Dear AGN Members,

Circular 3 of 2024 has bearing.

The AGN Office have started distributing 2024 ASA Permanent licenses since Monday, 22 January 2024. Please be reminded that 2023 Permanent Licenses are valid until 29 February 2024 and with effect from 01 March 2024 the 2024 licenses will become valid.

According to the AGN Constitution, all clubs should buy at least a minimum of 15 licenses as well as **pay affiliation fees by 31 March of the year in order to be eligible.**

Please note that permanent licenses are not restricted to athletes only and that eligibility are required for Board, Commission and Committee Members, as well as Coaches and Technical Officials.

2024 licenses will only be distributed to clubs based on the following requirements:

1. Paid 2024 affiliation fees – due by 31 March 2024
2. The office has received payment for the license order of a minimum of 15 licenses – please see 2024 license order form attached.
3. The office has been advised on your collection date and time – thus is avoid long queues and a smooth distribution process.
4. A completed and signed 2024 ASA license application form for each license (The attached 2024 ASA permanent license application form will be the only form AGN will accept and any amendments made to the form will not be accepted).

1. 2024 Affiliation Fees: - Clubs: R 1 250.00
- Schools: R 650.00
- Coaches: R 300.00
- Technical Officials: R 320.00
(Affiliation R 100.00 + License R 220.00)
2. 2024 License Fees: - Permanent license, Seniors: R 220.00
- Permanent license, Juniors: R 120.00
- Temporary license: R 60.00
3. 2024 Race Levies: - 8% to all finishers in all distances
Excluding 5km unofficial/fun run races
