The appeal application must contain the following information: 1) Name of the athlete; 2) ID number; 3) Name of the club where the athlete is affiliated; 4) ASA license number of the athlete; 5) Best Performances; 6) Date of Performance; 7) Name of race.

NB: Please note that no other information will be considered.

Very Important: If an athlete cannot participate or needs to withdraw from the team, it is of utmost importance to inform the AGN Office before Monday, 21 September 2026 at 16:00pm.
